Subject: Prior approval of the Government under section 68 of the Electricity Act, 2003 for "Western Region System Strengthening Scheme - XIV" - Reg.

Reference: PGCIL's letter no. C/CP/WRSS- XIV dated 27.11.2015

Sir

Reference is invited to the above mentioned letter, seeking prior approval of Government of India under Section 68(1) of Electricity Act, 2003, hereinafter "the Act", for PGCIL for the scheme – "Western Region System Strengthening Scheme - XIV", with following scope of works:

(i) Installation of 2 X 500 MVA, 400/220 kV transformers with associated bays at 765/400 kV Indore (PG) substation

(ii) 6 no. of 220 kV line bays at 765/400 kV Indore (PG) substation

(iii)Installation of 1 X 500 MVA, 400/220 kV transformer with a associated bays at 765/400 kV Itarsi (PG) substation

(iv)2 no. of 220 kV line bays at 765/400 kV Itarsi (PG) substation

- The scope of works mentioned above, have been agreed in 37th and 38th Standing Committee Meetings (SCM) on Power System Planning of Western Region held on 05.09.2014 and 17.07.2015, respectively.
- 3. CEA conveys the prior approval of Government under Section 68(1) of Electricity Act, 2003 to M/s PGCIL for the scheme 'Western Region System Strengthening Scheme XIV' with above scope of works.

4. This approval is subject to compliance of

- The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
- CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.

5. The approval is also subject to the following conditions:

(i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.

(ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one month notice.

(iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).

Provided that "nothing contained in this rule shall effect the powers conferred upon any licensee under section 164 of the Act"
