Subject: Prior approval of the Government of India under section 68 (1) of the Electricity Act, 2003 to M/s POWERGRID Corporation of India Ltd. (PGCIL) for the transmission scheme "Additional 2 no. of 220 kV line bays for 1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) Substation" - reg.

महोदय / महोदया, Sir / Madam,

Reference is invited to the above mentioned letter dated 24.05.2017, seeking prior approval of Government of India under Section 68 (1) of Electricity Act, 2003, in favor of M/s PGCIL for implementation of additional 2 no. of 220 kV line bays associated with 1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) Substation.

2. The 1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) Substation was agreed in 39th meeting of Standing Committee on Power System Planning of Western Region held on 30.11.2015. CEA vide letter dated 21.06.2016 has conveyed prior approval under Section 68 (1) of Electricity Act, 2003 for the scheme "Western Region System Strengthening Scheme – XVII" which included the 1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) substation. Subsequently, additional 2 no. of 220 kV line bays for

1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) Substation was agreed in the 41st meeting of Standing Committee on Power System Planning of Western Region held on 21.12.2016.

- 3. CEA conveys the prior approval of Government of India under Section 68 (1) of Electricity Act, 2003 to M/s PGCIL for implementation of the scheme "Additional 2 Nos. of 220 kV line bays associated with 1x500 MVA, 400/220 kV 3rd ICT at Khandwa (PG) Substation" with following scope of work:
 - i. Additional 2 no. of 220 kV line bays for 1x500 MVA, 400/220 kV 3rd ICT at 400/220 kV PKhandwa (PG) Substation
- 4. This approval is subject to compliance of
 - a) The relevant provisions of the Electricity Act, 2003, as amended from time to time and the rules and regulations made there under, and
 - b) CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
- 5. The approval is also subject to the following conditions:
 - (i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).

Provided that "nothing contained in this rule shall effect the powers conferred upon any licensee under section 164 of the Act".
