- i. SV Power TPS switchyard 400/132 kV ACBIL TPS switchyard 132 kV D/c line
- Prior approval u/s 68 (1) of the Electricity Act, 2003 for the above scope of works has already been granted to M/s ACBIL vide CEA letter dated 13.08.2019. Now, M/s SVPPL (a step down subsidiary of M/s ACBIL) has requested to grant the prior approval in their name.
- The connectivity line (SV Power TPS switchyard 400/132 kV ACBIL TPS switchyard 132 kV D/c line) has been agreed in 37th meeting of WR Constituents regarding Connectivity and LTA applications held on 25.04.2019 for grant of additional connectivity to M/s ACB (India) Limited (Lead Generator) for 1x63 MW

CTU had issued the connectivity intimation vide its letter dated 13.06.2019 with implementation of the connectivity line under the scope of M/s ACBIL. Subsequently, CTU vide its letter dated 19.11.2019 has modified the connectivity intimation with implementation of the connectivity line under the scope of M/s SVPPL.

- CEA conveys the prior approval of Government under Section 68(1) of Electricity 4. Act, 2003 to M/s SV Power Private Limited for the following overhead line under the transmission scheme "Additional Connectivity to M/s ACB (India) Limited (Lead Generator) for 1x63 MW TPS of M/s SV Power Ltd. at Korba, Chhattisgarh":
 - SV Power TPS switchyard 400/132 kV ACBIL TPS switchyard 132 kV D/c line
- 5. This approval is subject to compliance of
 - The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
 - CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and b) any subsequent amendments made thereto.
- The approval is also subject to the following conditions: 6.
 - The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
- This approval is the modified version of earlier issued approval vide CEA's letter 7. dated 13.08.2019.
