Sub: Prior approval of the Government of India under section 68(1) of the Electricity Act, 2003 to M/s Netra Wind Private Limited (NWPL) for the transmission scheme "Connectivity for 300 MW wind farms to M/s Netra Wind Private Limited in Kutch, Gujarat" - reg.

Sir,

M/s Netra Wind Private Limited (NWPL) vide its letter under reference 'i' has sought prior approval of the Government of India under section 68 (1) of the Electricity Act, 2003 for the transmission scheme "Connectivity for 300 MW wind farms to M/s Netra Wind Private Limited in Kutch, Gujarat" with the following scope of work:

- i. Netra Wind Power Limited – Bhuj PS 220 kV S/c line along with associated line bays at generation switchyard end (to be developed by the applicant)
2. Prior approval to M/s NWPL, under section 68(1) of the Electricity Act, 2003 has already been issued vide CEA's letter no. CEA-PS-11-23(20)/1/2018-PSPA-I Division-Part (1) dated 13.12.2019 for its connectivity at Bhuj-II PS.
3. Subsequently, the connectivity granted to M/s NWPL was changed from Bhuj-II pooling station to Bhuj pooling station on M/s NWPL request. The revised connectivity to M/s NWPL, as given above, has been discussed and agreed in 44th

meeting of WR Constituents regarding Connectivity and LTA applications held on 24.02.2020.

4. CEA conveys the prior approval of Government under Section 68(1) of Electricity Act, 2003 to M/s Netra Wind Private Limited for the following overhead line under the transmission scheme "Connectivity for 300 MW wind farms to M/s Netra Wind Private Limited in Kutch, Gujarat":
 - i. Netra Wind Power Limited – Bhuj PS 220 kV S/c line (with AL59 Moose conductor)
Line length is approx. 77 km, which would be implemented in three sections from NWPL switchyard to Bhuj PS:
 - (a) Section 1: 28.7 km 220 kV S/c line on S/C tower structure from NWPL switchyard to D/c tower starting point
 - (b) Section 2: 46 km 220 kV S/c line stringing on D/c towers of 220kV dedicated transmission line of M/s. Alfanar Energy Private Limited to Bhuj Pooling Station
 - (c) Section 2: 2.3 km 220 kV S/c line stringing on M/c towers (comprising of 4 ckts) of 220kV dedicated transmission line of M/s. Alfanar Energy Private Limited to Bhuj Pooling Station
5. This approval is subject to compliance of
 - a) The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
 - b) CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
6. The approval is also subject to the following conditions:
 - (i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
7. This prior approval supersedes the earlier prior approval issued vide CEA's letter no. CEA-PS-11-23(20)/1/2018-PSPA-I Division-Part (1) dated 13.12.2019.
