## महोदय/Sir,

CEA had vide Order No. CEA/Plg/RES-30/2017 dated 30<sup>th</sup> January, 2017 (Copy enclosed for ready reference) constituted a Technical Committee under the chairmanship of Member (Planning), CEA, for study of optimal location of the various types of balancing energy sources /energy storage devices to facilitate grid integration of Renewable Energy Sources (RES) and associated issues. The First meeting of the Committee was held on 23<sup>rd</sup> February, 2017 at CEA, New Delhi, followed by a meeting of the Sub-group for the Southern Region on 24<sup>th</sup> March, 2017 at SRPC, Bengaluru which was followed by second technical Committee meeting in Chennai for the Southern Region States on 09.05.2017. Third Technical Committee meeting in respect of the States of the Western Region was held at Vadodara on 05-06-2017.

The Fourth Meeting of the Technical Committee, specifically concerning the States of Northern Region will be held on 13<sup>th</sup> June, 2017 (Tuesday) at 10.30 A.M. at Northern Regional Power Committee, 18-A, Qutab Institutional Area, Shaheed Jeet Singh Marg, Katwaria Sarai, New Delhi-110 016. Tel: 011-26511211 (Member Secretary, NRPC Office), 011-26868681(EPABX). However, the States of other regions are also encouraged to attend the meeting.

#### The Proposed Agenda Items are as under:

- 1) The constituents of **Northern Region** in the Committee <u>may make a presentation</u> on adverse effects of variability of Wind and Solar generation and how they tackle the same at present. They may also give an assessment of loss of generation and of revenue, because of backing down of cheaper sources of conventional generation and losses due to Deviation Settlement Mechanism (DSM), purely on account of variability of renewable generation. Month wise data for 2016-17 and related details may be given to support the same.
- 2) Whether any <u>constraints</u> on transmission or distribution (T&D) system have been faced? If so, necessary augmentation of T&D infrastructure which needs to be undertaken <u>scope</u> and <u>financial</u> estimates for the same, if any, may be given.
- 3) To propose utilization of State's own balancing plants, wherever feasible.
- 4) An assessment of the quantum of electric storage system for balancing, which could be placed near the Renewable Energy (RE) generation sources.
- 5) Details of issues in the Grid Integration of Renewable Energy Generation Sources (RES) in **Northern Region** and the possible solutions.
- 6) Status of **Telemetry and Communication** system for Renewable Energy (RE) generators to SLDCs and data received through the same in a satisfactory manner on regular basis.
- 7) Status of establishment of Renewable Energy Management Centre (REMC) in the state and its linking to SLDC.
- 8) Any other item with the permission of the Chair.

It is requested that the nominated members of the Committee may please make it convenient to attend the above meeting. It is further requested that the concerned States from the Northern Region may list out the issues, and prepare power point presentation (PPT) for deliberation in the said meeting and e-mail the same to the undersigned so that the same can be circulated before the meeting for a comprehensive discussion.

Secretary of the Appropriate Commissions and of respective SERCs of the concerned constituents of the Northern Region States are requested to depute a senior officer from the Electricity Regulatory Commission to attend the meeting.

CMDs of M/s THDC, BBMB and SJVN Limited are requested to depute the concerned Officer from their respective Organisations, as special invitees to share their experience and make presentation to the Committee on proposed method of utilization of their Hydro Plants as a balancing source(s) for Renewable Energy (RE) integration.
