Subject: Retirement of Units 1 to 4 of 105 MW each capacity at Koradi TPS – regarding.


Sir,

Reference is invited to your letter No. CE/Works/CEA/Koradi/U-1-4/00085, dated 21-01-2016 seeking retirement of Units 1 to 4 of Koradi TPS of 105 MW each and removing this capacity from all India installed capacity (IC). The details furnished by MAHAGENCO have been examined by the Standing Committee on Deration, Upration and Retirement of Generating Units of Central Electricity Authority. It is seen that decision to retire these units has been taken by MAHAGENCO Board on 13-02-2012 as intimated by secretary, MSPGCL vide letter No. MSPGCL/BM-113/Item No. 113.8, dated 28-02-2012 which were already out of operation from 07-01-2011. It was resolved by the Board to close down the units permanently as intimated by MAHAGENCO vide letter No. MSPGCL/BM-113/Item No. 113.8, dated 28-02-2012.

It is seen that, before taking decision of retirement of the above units and taking them out of operation permanently CEA was not involved by MAHAGENCO. Thus examination of the issue by CEA and concurrence/approval for retirement is not considered relevant now.


However, the information from MAHAGENCO regarding decision to retire these units and taking these units out of operation permanently has been noted for suitable incorporation in our records of installed capacity.


