from 31.03.2017 - Approval by Board of TANGEDCO - Intimation - regarding.

Sir,

This is with reference to your above referred letter regarding intimation for decommissioning of unit-I to IV with installed capacity of 340 MW (2x60 + 2x110 MW) Ennore Thermal Power Station. It is seen that decision to retire this unit has been taken by Board of TANGEDCO in its 65<sup>th</sup> meeting held on 26.10.2016 has resolved the following for decommissioning of ETPS.

- To Shutdown the Units (Unit I to IV) permanently from 31.03.2017 and decommissioning of ETPS.
- To intimate CEA/New Delhi and other statutory bodies to exclude 450MW from the installed thermal generation station capacity of TANGEDCO.
- Further the Board directed that the existing officers and the staff may be beneficially utilized elsewhere without affecting their seniority and other benefits as being available to them now.

As TANGEDCO have already decided to retire the unit-I to IV permanently vide No. (Per) FB TANGEDCO Proc.No.72(Tech. Br.) dt 31-10-2016 and would be under permanent shut down from 31-03-2017.

The decision to retire Unit No I to IV of Ennore, TPS has been taken by TANGEDCO based on their own techno-economic reasons and based on their decision, the units are being deleted from our records of Installed Capacity from 31.03.2017.
