
Sir,

This is with reference to your above referred letter regarding proposal for retirement of unit-1 & 2 with installed capacity of 2x 120 MW of Gandhinagar Thermal Power Station. The details furnished by GSECL have been examined by the Standing Committee on Deration, Upration and Retirement of Generating Units of Central Electricity Authority. It is seen that decision to retire this unit has been taken by Board of GSECL in its 147th meeting held on 03.09.2016 has accorded approval vide B.R.No. 147.14.5035 for retirement of 2 x 120MW unit no. 1 & 2 of Gandhinagar TPS.

As GSECL have already retired the unit 1 & 2 as approved and is under permanent shut down from 06-03-2012, it is not desirable now to recommend retirement of this unit by CEA.


The decision to retire Unit No. 1 & 2 of Gandhinagar, TPS has been taken by GSECL based on their own techno-economic reasons and based on their decision, the unit is being deleted from our records of Installed Capacity. It is also intimated that provisions under section 25 (O) (Procedure for closing down on undertaking of Industrial Dispute Act) may be complied.
