# Report on the Electrical Safety Awareness Programme on 05.02.2020 at M/s ONGC, Uran, Maharashtra

#### **BACKGROUND:**

Electrical safety is more important as we could not apparently realise the amount of current a simple cable or bare conductor carrying or at a glance we could not ascertain whether a conductor live or dead. This harmless appearance could misguide us and this is root cause of most of electrical accidents. Therefore, safety must become an integral part of each working procedure.

In view of above and as per the directions of CEI Division, RIO's has been conducting awareness generation campaign in various cities/Industries etc. for the last three years. Accordingly, an electrical safety awareness programme was organised jointly by RIO (W), CEA & M/s ONGC, Uran in Maharashtra on 05/02/2020.

#### **Nomination of Participants:**

It was felt that participation from various Utilities/organizations, local bodies etc. were very much important in order to achieve the intention of the programme. RIO (W), CEA, Mumbai invited officers from Central PSUs like BPCL, GAIL, HPCL, JNPT, DP World and RCFL in the Uran area along with participants from M/s ONGC, Uran. A total of approx 50 nos. of participants were expected for the workshop.

As per the scheduled programme of the topics on Electrical safety, two sessions from RIO (W) were arranged.

All the special Guests have appreciated the efforts of CEA initiation and explained the necessity of Electrical safety
