Sensitization Workshop on Measures Relating to Electrical Safety and Electric Supply Regulations – 2010,

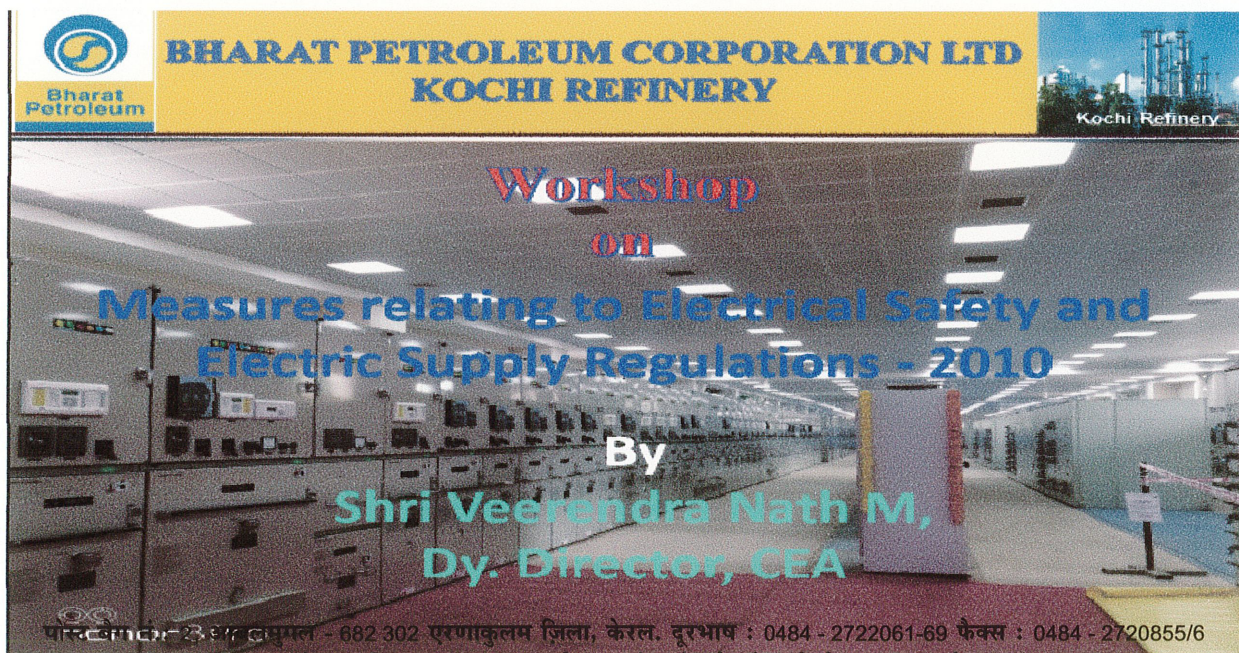

operation in LV switchboards that minimises hazards during racking in and out of modules.

Shri. Veerendranath, who was the Chief Guest cum Faculty for the Workshop conducted the training, explaining each safety related regulations of the Electric Supply Regulations – 2010. Regulations 19 and 27, 28 and 29 regarding General Safety requirements in Electrical Installations was stressed up on. Periodical inspection of Electrical installation as per Regulation 30 was also explained in detail. Regulation 33 regarding Precautions against leakage - IR value between each live wire and earth Regulation 35 regarding General conditions relating to supply and use of electricity were also discussed. The session was interactive and the Dy. Director gave clarifications to the queries raised by the participants.
