The PTCC proposal submitted vide above ref. (i) has been examined. The low frequency induction on BSNL cables and Block circuits of Northern Railways as per details furnished vide ref. (ii) and ref.(iii) respectively has been examined. The Soil Resistivity value has been taken as 15,000 Ohms-cm, as per data submitted by Power Authority. Voltages likely to be induced on paralleling BSNL cables and Railway block circuits under single line to ground fault condition are enclosed at Annex-I and Annex-II respectively. The screening factors as applicable have been considered. Defense has accorded NOC vide above ref. (iv) for this line (a copy enclosed at Annex-III). Taking above into consideration, kindly take necessary action regarding issue of PTCC route approval.
