The PTCC proposal submitted vide ref. (i) has been examined. BSNL vide ref. (ii) above has intimated that there are no U/G copper cable and no armoured OFC within 8 km of the proposed power line and vide ref. (iii) above, North Western Railway has also intimated that no railway track/ railway communication line exists within the vicinity of 8 km from the proposed power line. Accordingly, both BSNL and Railway has accorded No Objection Certificate (NOC). Defense has accorded NOC vide ref. (iv) above for this line (a copy enclosed at Annex-I).

Taking above into consideration, kindly take necessary action regarding issue of PTCC route approval.
