विषय: पतरातू एसटीपीपी (3x800MW) एसोसिएटेड ट्रांसमिशन सिस्टम की प्रगति की समीक्षा करने के लिए मीटिंग नोटिस.

**Subject:** Meeting notice to discuss progress of Associated Transmission System (ATS) for evacuation of Power from Patratu STPP (3x800MW) of NTPC – regarding.

महोदय/Sir,

This is to bring to your kind notice that Unit #1, Unit #2 & Unit #3 of Patratu STPP (3x800 MW) are likely to be commissioned by Mar'2022, Sep'2022 & Mar'2023. The development of Associated Transmission System by JUSNL is utmost important in the matching time frame for evacuation of power from Patratu STPS. Following transmission system for evacuation of power from Patratu STPP is being implemented by JUSNL.

1. Patratu - Patratu (JUSNL) 400kV (Quad) D/C line
2. Patratu - Chandil 400kV (Quad) D/C line
3. Chandil New - Chaibasa (PG) 400kV D/C line
4. Patratu- Koderma 400kV (Quad) D/C line

As per the latest status provided by JUSNL to CEA, above transmission system is under bidding stage and work is yet to be awarded under TBCB route. Since the construction work of the above lines is yet to start, it is a matter of serious concern that the commissioning of the Associated Transmission System(ATS) may not match with the above commissioning schedule of the Patratu STPP(3x800MW) and this huge capital cost project may become stranded due to non-availability of the power evacuation system.

PSPM Division, CEA has written letter to MD, JUSNL regarding delay in construction of Associated Transmission System of Patratu STPP (3x800MW) on 08.05.2020 and subsequent reminder on 06.07.2020, however no response from JUSNL has been received so far.

In this regard, Member (Power system) I/C & Chairperson, CEA, shall take a meeting to review the progress of Associated Transmission System of Patratu STPP (3x800MW) on **13.08.2020 at 12:30 PM** through Video Conferencing.
