Minutes of meeting taken by Chief Engineer(PSPM, CEA on 20.02.2018 to review the progress transmission work in J&K

List of participants is attached at Annexure-I.

2. Chief Engineer (PSPM) welcomed all participants and stated that this meeting has been called to review the progress of transmission lines for evacuation of power from Kishenganga HEP (3x110 MW) in J&K and its further transmission Amargarh(Delina) onward. He further stated that completion of Srinagar(Alusteng)-Leh 220 kV S/C transmission line of PGCIL is expected by Sept, 2018 and Srinagar(Alusteng) 220/132 kV substation and associated 220 kV line would be required in same time frame. He expressed his concern on the slow progress of transmission work in J&K by JKPDD. The progress of all the associated transmission lines in J&K were discussed in details. The gist of action points as emerged during discussions are as under:

(a) Amargarh (Delina)-Zainkote 220 kV D/C line and augmentation of transformation capacity at Amargarh (Delina) S/s

Only one ckt of Amargarh(Delina)-Zaikote 220 kV D/C line has been commissioned and both the ckts of 220 kV D/C line would be needed for smooth evacuation of power from Kishanganga HEP. Shri Khurshid, CE(JKPDD) informed that one circuit of this 220 kV D/C line was commissioned in June, 2013. Work on other circuit is completed but ckt could not be charged due to compensation issue at one location. He further stated that the matter of compensation issue has been reported to higher authority and expecting to resolve compensation issue soon. He stated that 2nd ckt of 220 kV D/C line would be commissioned by March, 2018. Sh Khurshid informed that Amargarh(Delina) is major load center and 220/132 kV substation at Delina has total capacity of 160 MVA, which is being augmented to 320 MVA. The augmentation work has been kept in the current transmission plan at an estd cost of Rs. 18.74 crs. Chief Engineer (PSPM) requested CE(JKPDD) to make effort for early commissioning of second ckt of Amargarh (Delina)-Zainkote 220 kV D/C line to avoid constraints in further transmission of power from Amargarh(Delina) after synchronization of Kishanganga HEP with the grid.

(b) LILO of Amargarh (Delina)-Zainkote 220 kV D/C line at Amargarh(Sterlite)

Chief Engineer(JKPDD) informed that construction of this 220 kV LILO line had been placed to Sterlite Grid. The representative of Sterlite Grid informed that all foundation and tower erection work has already been completed. The total length of lines(2xD/C) is about 3.2 km. Out of which 0.6 Km stringing has been completed. Representative of Sterlite Grid informed that LILO line would be commissioned by 07.03.18.

(c) Wagoora-Budgam-Zainkote 220 kV D/C line:

CE(JKPDD) informed that Construction work of this line has been affected due to severe ROW issues at Dangerpora in Budgam District. However, Wagoora to Budgam link would be completed using multi circuit tower by utilizing the existing corridor. JKPDD submitted details of RoW at under;

CE(JKPDD) stated that construction of line was affected due severe RoW issue and submitted detail of progress & RoW line section-wise as under;

Work stopped due to non-availability of fund and ECI shall resume work by first week of April 18 with the commissioning schedule of 10/2018.

Work stopped due to non-availability of fund. Balance work has been retendered and work is expected to be allotted by last of April 18 with the commissioning schedule of 10/2019.

(f) 220/132 kV Alusteng S/S:

CE(JKPDD) stated that erection of structure on 132 kV and 33 kV side has been done and commissioning of 2x50 MVA, 132/33 kV S/S is expected by Jun, 18 by LILO of existing USHP-Habbak 132 kV line at alusteng. CE(JKPDD) stated that work at substation had been stopped in 2014 due to paucity of fund and also contractor(Jyoti structure) had withdrawn his man and machine from site due to companies internal financial problem . JKPDD has already terminated the contract and the balance are being executed by JKPDD at the risk and cost of the contractor. He further stated that fund has now been received and 220/132 kV Alusteng S/S is targeted to commission in Oct, 2018.

M/s PGCIL informed that completion of Alusteng-Leh 220 kV line is expected by Sep, 2018 and 220 kV bays at Alusteng S/S would be required for its termination. CE(PSPM) reiterated that commissioning of 220/132 kV Alusteng S/S along with associated 220 kV lines by Sept, 2018 is prerequisite for commission of Alusteng-leh 220 kV line of PGCIL. CE(JKPDD) ensured that commissioning of Zainkote - Alusteng 220 kV line and 220/132 kV Alusteng S/S would match commissioning of Srinagar – Leh line.

(g) Kishenganga – Amargarh(Delina) 220 kV D/C line & Kishenganga - Wagoora 220 kV D/C line

Regarding progress of Kishenganga- Amargarh 220 kV D/C line, PGCIL informed that stringing of 3.41 Km is left and same would be completed. The line would be back charged by 23.02.2018. Regarding, issue of about 6 cm sinking observed at 1 no. tower, PGCIL informed that they have planned to by-pass this tower and only one double ckt would be strung in the span. He stated that there would not be any electrical clearance issue. At the sinking tower location, the tower would be dismantled and piling foundation would be casted. PGCIL representative stated that Kishenganga - Wagoora 220 kV D/C line would be completed by Jun, 2018. PGCIL representative stated that JKPDD may ensure further transmission of power from Delina s/s onward. CE(JKPDD) stated that second circuiting of Delina-Zainkote 220 KV line would also be completed by M/s JKPDD by Mar, 2018 for evacuation of power from Kishenganga HEP.

(h) LILO of Uri-Wagoora 400 kV line at Amargarh (SGL):

M/s Sterlite Grid Limited informed that foundation and tower erection work for this line is complete and string has been done in 5.8 km out of 6.8 km. Shut down will be required for final stretch stringing. Target for completion is by first week of March, 2018.
