Minutes of the Meeting taken by Chairperson, CEA on 19.03.2018 regarding the issues related to Transmission System of North Karanpura Project (3x660MW) of NTPC

List of participants is enclosed at Annexure-I.

Pursuant to the decision taken in the meeting chaired by Secretary, Power on 14.03.2018 for resolving the issues pertaining to NKSTPP – Chandwa 400 kV line and NKSTPP – Gaya 400 kV line covered under the Transmission System of North Karanpura generation project, a meeting was taken by Chairperson, CEA at Sewa Bhawan, New Delhi on 19.03.2018. Chief Engineer, PSPM informed that the construction work on North Karanpura-Chandwa and North Karanpura-Gaya Transmission lines couldn't be started due to non receipt of "NOC" from Central Coalfields Ltd.(CCL). As desired by CCL, the requisite undertaking has also been submitted by M/s NKTL for shifting the transmission lines, as and when required, after receiving the advance notice of 24 months from CCL.

Representative of Ministry of Coal informed that during the aforesaid meeting taken by Secretary(Power), Joint Secretary, Ministry of Coal had clarified that the undertaking given by M/s NKTL would not suffice the purpose and hence, an undertaking from an appropriate agency of Ministry of Power would be required for re-routing the lines, as and when the land is needed, by CCL for mining activity at a later stage.

To the queries on additional cost in case of re-routing of transmission line(s) in future, representative of NKTL informed that whenever such situation arises, they would approach CERC for revision of tariff.

For getting the background of the matter, Member(E&C) enquired from the Bid Process Co-ordinator (BPC) i.e RECPTCL whether all the three options of routes of Transmission Lines given in the RFP document, were traversing through coal bearing area on their way. Representative of BPC replied that the CCL had not notified / acquired land for mining of coal at the time of route survey and award of transmission project to NKTL i.e in May 2016. Chairperson, CEA stated that CEA is not a commercial organization, it is a statutory body under Ministry of Power which advises Govt. of India on technical matters and in this case, CEA can only facilitate in re-routing of the transmission lines as per requirement of CCL in future. In order to fulfill the requirement of Ministry of Coal, he advised representative of MoC and CEA to discuss and finalise the letter to be issued to MoC so that NOC can be issued by MoC to M/s NKTL for construction of lines.

The meeting ended with thanks to Chair.
