CORRIGENDUM

In the e-Tender for Supply & Installation of Desktop Computer & MS Office in CEA (No. CEA/PCE-I/ IT/ PLAN/UITI/2015, Dated: 16.09.2015), the following clauses are modified as under:

Clause 6.6.1: The words & figures “*clause 6.1.18*” shall be substituted by “*clause 6.18*” and the words & figures “*Clarification / Queries received, only, by 11:00 am on 5th October, 2015, will be entertained*” shall be inserted after the first sentence.

Clause 6.8.3: The following words & figures shall be inserted after the last sentence:

“If during the installation & commissioning, it is found that more than 10% of the ordered quantity of Desktop Computers fail to perform as per technical specifications, then the purchaser shall have right to reject all the Desktop computers supplied and the Performance Security shall be encashed.”

Clause 6.8.4: Deleted

Clause 6.9.1: The words “*after completion of supply, installation & commissioning*” shall be deleted.

Clause 6.11.5: The words “*or abroad*” shall be deleted.

Clause 6.18: The figures “*6.13*” shall be replaced by “*6.14*”.
