Sir / Madam,

Reference is invited to the letter mentioned under reference 'i' & 'ii', seeking prior approval of Government of India under Section 68(1) of Electricity Act, 2003, in favor of M/s Wind World India Limited (WWIL) for the transmission scheme "Connectivity System of 500 MW Wind Farms in Walka Mota, Bhuj, Gujarat", with following scope of work:

- i. WWIL (Walka Mota) – Bhuj PS 220 kV D/c (twin ACSR moose equivalent conductor) line along with associated line bays at both ends
2. The above transmission scheme, with its specified scope of work, has been agreed in 41<sup>st</sup> meeting of Standing Committee on Power System Planning of Western Region / 24<sup>th</sup> meeting of WR constituents for connectivity & LTA applications held on 21.12.2016.
3. Central Electricity Authority, Government of India, conveys prior approval of the Government under Section 68(1) of Electricity Act, 2003 to M/s Wind World India Limited (WWIL) for the


transmission scheme "Connectivity System of 500 MW Wind Farms in Walka Mota, Bhuj, Gujarat" with following scope of work.

- i. **WWIL (Walka Mota) – Bhuj PS 220 kV D/c (twin ACSR moose equivalent conductor) line\***

**\*The transmission towers in the vicinity of Bhuj pooling stations may be of multi circuit type for the optimization of RoW**

4. This approval is subject to compliance of
- The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
  - CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
5. The approval is also subject to the following conditions:
- The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
  - Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
  - The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extraordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
