Subject: Prior approval under Section 68(1) of Electricity Act, 2003 to M/s Torrent Power Limited (TPL) for the transmission scheme "Connectivity system of M/s Torrent Power Limited for its 199.50 MW Junachay and 115 MW Nakhatrana wind farms in Kutch, Gujarat" - regd.

Sir,

Reference is invited to the above mentioned letter, seeking prior approval of Government of India under Section 68(1) of Electricity Act, 2003, in favor of M/s Torrent Power Limited (TPL) for the transmission scheme "Connectivity system of M/s Torrent Power Limited for its 199.50 MW Junachay and 115 MW Nakhatrana wind farms in Kutch, Gujarat" with following scope of work:

- (i) TPL(Junachay) - TPL(Nakhatrana) - Bhuj PS 220 kV S/c line [TPL(Nakhatrana) - Bhuj PS 220 kV S/c line would be of minimum 315 MW capacity at nominal voltage] along with associated bays at Bhuj PS and generation switchyard.*

* The line TPL(Junachay) - TPL(Nakhatrana) - Bhuj PS would be implemented in five sections as under:

- a) Section 1: 3 km D/c line on D/c tower by M/s TPL (both circuits would be strung and bunched at TPL Junachay end)
 - b) Section 2: 28 km D/c line would be strung on M/c towers of M/s TPL (2 circuits would be strung and bunched at M/c tower ending point)
 - c) Section 3: 4 km S/c line would be strung on M/c towers of M/s Avikiran Solar India Pvt Ltd (ASIPL)
 - d) Section 4: 30 km D/c line on D/c tower by M/s TPL (two circuits would be strung to establish LILO of TPL (Junachay) - Bhuj 220kV S/c line at TPL Nakhatrana)
 - e) Section 5: 29-30 km S/c line would be strung on M/c towers of M/s Green Infra Wind Energy Limited (GIWEL)
2. The above transmission scheme with its specified scope of work, has been agreed in 1st meeting of Western Region Standing Committee on Transmission (WRSCT) held on 05.09.2018 and the common transmission system for TPL (Junachay) and TPL Nakhatrana wind farms was agreed in 29th meeting of WR Constituents regarding Connectivity & Long-Term Access applications in Western Region held on 17.08.2018.
3. CEA conveys the prior approval of Government under Section 68(1) of Electricity Act, 2003 to M/s Torrent Power Limited for the following overhead line under the transmission scheme "Connectivity system of M/s Torrent Power Limited for its 199.50 MW Junachay and 115 MW Nakhatrana wind farms in Kutch, Gujarat":
- (i) TPL (Junachay) – TPL (Nakhatrana) - Bhuj PS 220 kV S/c line [TPL(Nakhatrana) - Bhuj PS 220 kV S/c line would be of minimum 315 MW capacity at nominal voltage] *
- * The line TPL (Junachay) – TPL (Nakhatrana) - Bhuj PS would be implemented in sections as mentioned above.
4. This approval is subject to compliance of
- a) The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
 - b) CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
5. The approval is also subject to the following conditions:
- (i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of
