महोदय / महोदया, Sir / Madam,

Reference is invited to PGCIL's letter dated 12.09.2016, seeking prior approval of CEA, MoP, Government of India under Section 68 (1) of Electricity Act, 2003, hereinafter "the Act", in favor of M/s PGCIL for implementation of – "POWERGRID Works associated with Additional system for Power Evacuation from Generation Projects pooled at Raigarh (Tamnar) Pool", with following scope of work:

- i. 2 nos. of 765 kV line bays at Dharamajaygarh Pooling station
(for termination of Dharamajaygarh Pooling station section B – Raigarh (Tamnar) PS 765 kV D/C line. This line is to be implemented under TBCB).
- ii. 2 nos. of 765 kV line bays at Raigarh (Tamnar) PS Pooling station
(for termination of Dharamajaygarh Pooling station section B – Raigarh (Tamnar) PS 765 kV D/C line. This line is to be implemented under TBCB).

2. The scheme 'Additional system for Power Evacuation from Generation Projects pooled at Raigarh (Tamnar) Pool' has been agreed in 39th Standing Committee Meeting (SCM) on Power System Planning of Western Region held on 30.11.2015. Subsequently, POWERGRID works associated with the scheme 'Additional system for Power Evacuation from Generation Projects pooled at Raigarh (Tamnar) Pool' were approved in the 36th meeting of Empowered Committee on Transmission held on 26.07.2016.
3. CEA conveys the prior approval of Government of India under Section 68 (1) of Electricity Act, 2003 to M/s PGCIL for implementation of 'POWERGRID Works associated with Additional system for Power Evacuation from Generation Projects pooled at Raigarh (Tamnar) Pool' with its above specified scope of work.
4. This approval is subject to compliance of
 - a) The relevant provisions of the Act, as amended from time to time and the rules and regulations made there under, and
 - b) CEA (Measures relating to Safety and Electrical Supply) Regulations, 2010 and any subsequent amendments made thereto.
5. The approval is also subject to the following conditions:
 - (i) The implementing agency will commence construction of the project within three years of grant of approval, unless this term is extended by the Central Electricity Authority.
 - (ii) Central Electricity Authority may withdraw the approval before the expiry of the period of three years after giving a one-month notice.
 - (iii) The implementing agencies shall abide by the provisions of Works of Licensee Rules, 2006 notified by the Govt. of India, Ministry of Power in the Gazette of India, extra-ordinary Part-II, Section 3(i) dated 18-04-2006 (vide GSR 217 (E) dated 18-04-2006).
Provided that "nothing contained in this rule shall effect the powers conferred upon any licensee under section 164 of the Act".
