Retirement/decommissioning of units 1, 2 & 3 of Maithon Gas Power Station (MGPS) of 30 MW installed capacity each – regarding.

Sir.

Reference is invited to your letter No. EDCON/R&M/GT-Maithon/68, dated 01-03-2016 seeking retirement of Maithon Gas Turbines Unit No. 1 to 3 (3x30 MW). The details furnished by DVC in this regard have been examined by the Standing Committee on Deration, Upration and Retirement of Generating Units of Central Electricity Authority. It is seen that decision to explore possibility of sale/ lease these units has been taken by DVC board in thier meeting on 09-12-2006 vide resolution No.7566 and thereafter DVC board in its 619th meeting on 19th November, 2014 vide resolution No.8583 have accorded approval to the retirement of the units 1,2 & 3. All these units which were out of operation since July,1999, November, 2003 & May, 1996 respectively.

As the units have been out of operation for the last 10-15 years and DVC have already retired them, it is not desirable to recommend retirement of these units by CEA which are almost unused assets.

However, the intimation by DVC regarding their decision to close these 3 units of MGPS (3x30 MW) and taking these units out of operation permanently has been noted for suitable incorporation in our records of installed capacity.
