Sir.

This is with reference to your above referred letter regarding proposal for retirement of unit-V with installed capacity of 110 MW Ennore Thermal Power Station. The details furnished by TANGEDCO have been examined by the Standing Committee on Deration, Upration and Retirement of Generating Units of Central Electricity Authority. It is seen that decision to retire this unit has been taken by Board of TANGEDCO in its 38th meeting held on 28.06.2013 has accorded approval for the following:

(i) To keep the Unit V under shut down condition till decommissioning of the station and utilize the available spares in other needy Units.

(ii) To exclude the capacity of Unit-V of 110 MW from the station installed capacity of 450 MW and to derate the station to 340MW.

As TANGEDCO have already retired the unit-V as approved vide No. (Per) FB TANGEDCO Proc.No.70(Tech. Br.) dt 04-07-2013 and is under permanent shut down from 06-03-2012, it is not desirable now to recommend retirement of this unit by CEA.

The decision to retire Unit No. V of Ennore, TPS has been taken by TANGEDCO based on their own techno-economic reasons and based on their decision, the unit is being deleted from our records of Installed Capacity.
