विषय/ Sub: Approval of Designated Authority for Export of Power to NEA, Nepal through Muzaffarpur - Dhalkebar 400 kV D/C line from Indian Power Exchanges(s) -reg.

महोदय/Sir,

This has reference to NTPC Vidyut Vyapar Nigam Limited (NVVN) application no. NVVN/Comml/DA Approval/ dated 11.01.2023 seeking approval of Designated Authority (DA) for export of power to Nepal Electricity Authority (NEA), Nepal, from Indian Power Exchange(s) - Day Ahead Market through Muzaffarpur - Dhalkebar 400kV D/C line for a period from 1st April, 2023 to 31st March, 2024.

1. Key aspects of the proposed transactions are as under:
 - (i) Quantum proposed: upto 400 MW (only for PX- DAM)
 - (ii) Time period: 1st April, 2023 to 31st March, 2024.
 - (iii) Drawal point: 400 kV Muzaffarpur end of Muzaffarpur-Dhalkebar Line.
2. The matter has been examined in accordance with the Guidelines for Import/Export (Cross Border) of Electricity- 2018 and Procedure for Approval and facilitating Import/Export (Cross Border) of Electricity. Accordingly, approval of Designated Authority is hereby conveyed to NTPC Vidyut Vyapar Nigam Limited (NVVN) for export of upto 400 MW of power to Nepal Electricity Authority (NEA), Nepal, from

Indian Power Exchange(s) - Day Ahead Market through Muzaffarpur - Dhalkebar 400kV D/C line for a period from 1st April, 2023 to 31st March, 2024.

3. This approval is subject to the following conditions:

- (a) Govt. of India reserves the right to import/ export electricity from/ to neighbouring countries for reason of larger policy interests, and same shall be binding on the Participating Entity.
- (b) NRVN and other participating entities, involved in this transaction, shall comply with the applicable Rules/Guidelines/Regulations/Standards of Government of India/CEA/CERC. The grant of approval by the Designated Authority for participation in Import/Export (Cross Border) of Electricity shall not entitle NRVN any rights or extra privileges over and above the applicable laws.
