महोदय(Sir),


This has reference to the application of Sembcorp Gayatri Power Limited received vide your letter no. SGPL/COM-PS/BPDB/LT-250/18-19/65 dated 10.08.2018 seeking approval of the Designated Authority (DA) for participation in CBTE for export of 250MW of power to Bangladesh Power Development Board (BPDB) under short term and long term.

1. The proposal of M/s Sembcorp Gayatri Power Limited, as participating entity, for export of 250MW of power to BPDB has been examined and is found to be in order.
2. Accordingly, the Designated Authority conveys its approval to Sembcorp Gayatri Power Limited, as participating entity, as per the Guidelines on CBTE issued by MoP in December 2016, for participation in CBTE for export of 250MW of power to BPDB under Short term (from 1<sup>st</sup> August 2018 to 31<sup>st</sup> December 2019) and Long term (from 1<sup>st</sup> January 2020 to 31<sup>st</sup> July 2033).

3. This approval is subject to following conditions:
- The approval shall be valid for export of electricity by Sembcorp Gayatri Power Limited to BPDB as per the period indicated in the Lol.
  - The approval shall not mean availability of cross border corridor for scheduling of power to neighbouring countries.
  - The Participating Entity shall submit a copy of PPA within 15 days of signing.
  - The cross border transaction of electricity by Sembcorp Gayatri Power Limited shall be governed by the Regulations framed by Central Electricity Regulatory Commission (CERC) of India.
  - The approval will be subject to complying with applicable sections of the Electricity Act 2003, Regulations made thereunder and any other applicable laws, rules, regulations, policies and guidelines of Government of India.
  - The Designated Authority shall, in any form, not be made party to any loss, damage, disputes or problems arising out with respect to an entity approved by the Designated Authority for carrying out cross-border trade in electricity, for and against any claim, demand, liability, action, proceedings, cost or expense in favour of participating entities or any other third entity.
