महोदय(Sir),

This has reference to the application of Adani Power (Jharkhand) Limited (APJL) received vide your letter no. APJL/CEA/02062018 dated 02.06.2018 seeking approval of the Designated Authority (DA) for participation in CBTE for export of 1496MW of power to Bangladesh Power Development Board (BPDB) from Godda Thermal Power Project of APJL through their independent transmission line under long term PPA for 25 years.

- 1. The proposal of Adani Power (Jharkhand) Limited (APJL), as participating entity, for export of 1496 MW of power to BPDB, as submitted vide above letter, has been examined and is found to be in order.
- 2. Accordingly, the Designated Authority conveys its approval to Adani Power (Jharkhand) Limited (APJL), as participating entity, as per the Guidelines on CBTE issued by MoP in December 2016, for participation in CBTE for export of 1496MW of power to BPDB under Long term (from December 2021 for a period of 25 years).

- 3. This approval is subject to following conditions:
  - a) The approval shall be valid for export of electricity by APJL to BPDB through an independent transmission line for a period of 25 years starting from December 2021.
  - b) The Participating Entity shall submit a copy of PPA within 15 days of signing.
  - c) The approval will be subject to complying with applicable sections of the Electricity Act 2003, Regulations made thereunder and any other applicable laws, rules, regulations, policies and guidelines of Government of India.
  - d) The Designated Authority shall, in any form, not be made party to any loss, damage, disputes or problems arising out with respect to an entity approved by the Designated Authority for carrying out crossborder trade in electricity, for and against any claim, demand, liability, action, proceedings, cost or expense in favour of participating entities or any other third entity.
