**विषय/Subject: Modification in the approval of Designated Authority for export of power to Nepal from Indian Power Exchange(s) (PX) through 132 kV line from U.P. – reg.**

महोदय/Sir,

1. This has reference to PTCIL application No. C/PTC/MTFG/CEA/1035 dated 22.03.2024 seeking modification in the approval of Designated Authority dated 21.03.2024 for export of power to Nepal through New Nautanwa (U.P.)- Mainahiya (Nepal) 132 kV D/c transmission line.
2. Earlier, PTCIL vide application no. C/PTC/MTFG/CEA/255 dated 12.01.2024 sought approval of Designated Authority (DA) for export of upto 150 MW power to Nepal Electricity Authority (NEA), Nepal, from Indian Power Exchange(s) – {Both Day Ahead Market (DAM) and Real Time Market (RTM)} through New Nautanwa (U.P.)- Mainahiya (Nepal) 132 kV D/c transmission line for a period from 12<sup>th</sup> March, 2024 to 15<sup>th</sup> June, 2024.
3. Based on the concurrence of MoP, Designated Authority vide letter dated 21.03.2024 conveyed the approval to PTCIL for export of upto 150 MW power to Nepal Electricity Authority (NEA), Nepal, from Indian Power Exchange(s) – {Both Day Ahead Market (DAM) and Real Time Market (RTM)} through New Nautanwa (U.P.)- Mainahiya (Nepal) 132 kV D/c transmission line for a period from **21<sup>st</sup> March, 2024 to 31<sup>th</sup> March, 2024** restricted to **Solar-hours only** and subjected to **transmission constraints**.
4. PTCIL vide letter dated 22.03.2024 requested for the modification in the approval of Designated Authority for export of upto 150 MW power to Nepal Electricity Authority (NEA), Nepal, from Indian Power Exchange(s) – {Both Day Ahead Market (DAM) and Real Time Market (RTM)} through New Nautanwa (U.P.)- Mainahiya


(Nepal) 132 kV D/c transmission line for the period from 1<sup>st</sup> April, 2024 to 15<sup>th</sup> June, 2024 on Round the Clock (RTC) basis.

5. The matter has been examined in accordance with the Guidelines for Import/Export (Cross Border) of Electricity- 2018 and Procedure for Approval and facilitating Import/Export (Cross Border) of Electricity. Based on the revised concurrence from MoP, the approval of Designated Authority dated 21.03.2024 conveyed to PTCIL for export of power to Nepal through New Nautanwa (U.P.)- Mainahiya (Nepal) 132 kV D/c transmission line stands modified as under:
