**विषय/ Sub: Approval of Designated Authority for import of power from Lower Modi Hydro Power Project, Nepal through NVVN in Indian Power Exchange(s) -reg.**

महोदय/Sir,

This has reference to NTPC Vidyut Vyapar Nigam Limited (NVVN) application no NVVN/CommDA/Modi dated 21.03.2024 seeking approval of Designated Authority (DA) for import of upto 19.4 MW of power from Lower Modi Hydro Power Project, Nepal through NVVN in Indian Power Exchange(s) (PX) – {Both Day Ahead Market (DAM) and Real Time Market (RTM)} for a period from 1<sup>st</sup> October, 2024 – 30<sup>th</sup> September, 2025.

1. Key aspects of the proposed transactions are as under:
  - a) Quantum proposed: upto 19.4 MW (Power Exchange- Both DAM and RTM)
  - b) Time period: 1<sup>st</sup> October, 2024 – 30<sup>th</sup> September, 2025
  - c) Injection point: Muzaffarpur end of Muzaffarpur-Dhalkebar Transmission line
  - d) Name of the Generating Station: Lower Modi Hydro Power Project
  - e) Name of the Generating Company: Modi Energy Limited
2. The matter has been examined in accordance with the Guidelines for Import/Export (Cross Border) of Electricity- 2018 and Procedure for Approval and facilitating Import/Export (Cross Border) of Electricity. Based on the concurrence from MoP, approval of Designated Authority is hereby conveyed to NTPC Vidyut Vyapar Nigam Limited (NVVN) for import of upto 19.4 MW of power from Lower Modi Hydro Power Project, Nepal through NVVN in Indian Power Exchange(s) (PX) – {Both Day Ahead Market (DAM) and Real Time Market (RTM)} for a period from 1<sup>st</sup> October, 2024 – 30<sup>th</sup> September, 2025.

3. This approval is subject to the following conditions:
- (a) Real time generation data (MW, MVAR, etc.) and daily energy generation (MWh) of the Lower Modi Hydro Power Project shall be made available to NLDC, India.
  - (b) In case, there is a change in the equity pattern of Modi Energy Limited, NVVN shall intimate the Designated Authority within thirty (30) days from such change in equity pattern for continuation of the approval.
  - (c) Govt. of India reserves the right to import/ export electricity from/ to neighbouring countries for reason of larger policy interests, and same shall be binding on the Participating Entity.
  - (d) Scheduling of power from the generating station to Indian Power Exchange(s) shall be restricted to capacity available in transmission line.
  - (e) NVVN and other participating entities, involved in this transaction, shall comply with the applicable Rules/Guidelines/Regulations/Standards of Government of India/CEA/CERC. The grant of approval by the Designated Authority for participation in Import/Export (Cross Border) of Electricity shall not entitle NVVN any rights or extra privileges over and above the applicable laws.
