**विषय: केन्द्रीय विद्युत प्राधिकरण (के.वि.प्रा.), विद्युत् मंत्रालय की वार्षिक रिपोर्ट 2020-21 के संबंध में।**

अधोहस्ताक्षरी को यह सूचित करने का निर्देश हुआ है कि केन्द्रीय विद्युत प्राधिकरण (के.वि.प्रा.) की वार्षिक रिपोर्ट तैयार करने का कार्य समन्वय प्रभाग को सौंपा गया है। इस सम्बन्ध में के.वि.प्रा. के सभी डिवीजनों/ सेक्शनों से यह अनुरोध किया जाता है कि **31.03.2021** तक के डेटा को तैयार/ संकलित कर समन्वय प्रभाग को ई-मेल [cecdcea@nic.in](mailto:cecdcea@nic.in) पर उपलब्ध कराएं। सूचना के पैटर्न को उसी लाइन पर रखें जैसा कि के.वि.प्रा. की वर्ष 2019-20 की वार्षिक रिपोर्ट में प्रस्तुत किया गया था।

**नियत कार्य की समय पर पूर्ति सुनिश्चित करने के लिए निम्नलिखित बिन्दुएं आवश्यक हैं:**

1. All the Divisions of the Wings may compile their part of information and send it to the concerned SA for consolidation so that one set of information from the Wing be submitted with final approval of the concerned Member. This would ensure comprehensiveness of the information and to avoid any duplicity of information.
2. Administration Division/ Wing may compile and furnish its consolidated material taking inputs from all sections under it i.e. Budget & Accounts, Vigilance, Administration/ Personnel, Protocol Unit, General Services, Technical Services, etc. as one set of information with due approval of Secretary, CEA.
3. Power Communication Development (PCD), Legal and HRD Divisions are required to forward the requisite information with due approval of Principal Chief Engineer-I.
4. Coordination and Information Technology (IT) Divisions are required to forward the requisite information with due approval of Principal Chief Engineer-II.
5. The Regional Power Committees (RPCs) are to forward their information to GM Division for appropriate integration in the consolidated material from GM Division/ GO&D Wing.

6. The Regional Inspectorate Offices (RIOs) would submit their information to CEI Division for appropriate incorporation in the consolidated material from CEI Division/ Power System Wing.
7. The Regional Power Survey Offices (RPSOs) are to forward their information to PS&LF Division for appropriate incorporation in the consolidated material from PS&LF Division/ Planning Wing.
