**OFFICE ORDER No. 64/2021**

In pursuance of Ministry of Power OM No. A-33012/01/2015-Adm.I dated 10<sup>th</sup> July 2015 and further amended vide O.M. dated 10<sup>th</sup> March, 2017, Shri Saurabh Mishra working as Deputy Director in Pay Level 11 Scale of Pay of Rs.67700-208700 is deputed under the scheme for mandatory Hands-on-Exposure/Field Posting of Central Power Engineering (Group A) Service Officers of Central Electricity Authority to Power Grid Corporation of India Limited (PGCIL) for a period of 1½ years (18 months) with effect from the date of assumption of charge in PGCIL.
