CIRCULAR

Sub: <u>SELECTION TRIALS FOR PARTICIPATION IN THE INTER-MINISTRY ATHLETICS MEET 2021-22.</u>

All the officers/officials of CEA(headquarter), who desire to participate in the Inter-Ministry Athletics Meet 2021-22 to be held from 25-27 October, 2021 at Jawahar Lal Nehru Stadium (Warm up Area), New Delhi. are requested to attend the selection trails which will be held on 20.10.2021 from 3 PM onward at CCSCSB Sports Complex, Vinay Marg, New Delhi.

- 2. Those officers/officials who will be selected after the Selection Trials for their participating in the above said Inter-Ministry Athletics Meet, must submit their final willingness along with "No Objection Certificate" from their respective controlling officers.
- 3. Shri Satish Kumar (State level Athlete) has been appointed as Selector (External appointed) of the above said Selection Trials. His decision will be final and binding and no further request will be entertained in any condition in this regard.
- 4. All the participants are requested to report to the above said Selector at the above said venue with proper kit on 20.10.2021 at 2.30 PM Sharp. Those who are not in proper kit, will not be allowed to participate in the Selection/Trials.
- 5. <u>Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)-</u> Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:

All the players are directed to follow these guidelines/protocol/instructions strictly during the selection trials as per Annexure(I). Check-List for Covid-19 is also required to be filled at the Venue(Annexure-II)

<u>Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)- Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:</u>

- 1. A SCREENING CHECK LIST for COVID-19(Annexure-I) is mandatory to fill up at the venue.
- 2. While coming at the venue, all the Players/Officials may ensure and implement the instructions strictly as issued by the MHA time to time Vide O.M./Orders Nos.40-3/2020-DM-I(A), dated 15.04.2020, 01.05.2020, 17.05.2020, 29.06.2020, 30.09.2020, 25.11.2020, 28.12.2020, 27.01.2021/DoPT O.M. No. 11013/9/2014-Estt.A.III, dated 18.05.2020 and M/o YA&S Circular(SOP), dated 26.12.2020 & 29.01.2021 respectively i.e. social distancing, wearing face cover/mask, time to time hand sanitization, strict ban of gutka/Tobacco etc. and spitting should be strictly prohibited, stagger the lunch break of staff, to ensure social distancing etc.
- 3. Personal equipment such as Kit Bag, towel, wrist band, head band, shoes, T-Shirt, Short etc. shall be used without sharing.
- 4. While not in playing hall, wash your hands with soap even when hands are not visibly dirty. Use of alcohol based hand sanitizers can be made wherever feasible.
- 5. Face cover/mask have to be worn at all times at inside or outside the venue except playing match at the Badminton Court. Use covered dustbins to manage used masks and waste materials.
- 6. Distance of 6 feet shall be maintained while sitting or walking inside or outside the venue.
- 7. Use of 'AROGYA SETU' app: Arogya Setu enables early identification of potential risk of infection thus act as a shield for individuals and the community. With a view to ensuring safety at the venue, all the Players & Officials should ensure that 'AROGYA SETU' is installed by them in their compatible mobile.
- 8. If any Player/Official or his/her family member/relative is suspected/tested for COVID-19 to whom the Player/Official has been sharing common living space or has been in contact, then it is expected of the concerned Player/Official to inform the S.O.(Welfare)/Covid Task Force at venue/office immediately and refrain from attending the selection trials/office to prevent risk of exposing others in the tournament/office as has been specified in the Standard Operating Procedure (SOP) issued by M/o H&FW on 04.06.2020.
- 9. Strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly. Spitting will be strictly prohibited.
- 10. All the players/officials are requested to cooperate with the Selectors, who have also act as a Covid Task Force during the selection trials.
- 11. If it is found that above mentioned protocol/Guidelines is not followed by any player/official in the selection trials including inside or outside venue premises, he/she shall be liable to scratched from the selection trials.
- 12.All the Players/Officials are directed to follow these instructions without fail. Cooperation of all Players and Officials is crucial to contain the spread of infection.
