CIRCULAR

Sub: <u>SELECTION TRIALS FOR PARTICIPATION IN THE 11th INTER-CPSU MEN & WOMEN ATHLETICS TOURNAMENT 2021-22.</u>

Inter CPSU Men & Women Athletics Tournament 2021-22 to be organized by Bhakra Beas Management Board (BBMS) under the aegis of Power Sports Control Board, Ministry of Power at Nangal Township w.e.f. 11th to 12th March, 2022.

2. The details of game events to be played are as under:

For Men

100 mtr., 200 mtr., 400 mtr., 800 mtr., 1500 mtr., 400x100 mtr. Relay

Race, Long Jump, Triple Jump, High Jump, Shot-Put, Discus Throw,

Javelin Throw.

For Women:

100 mtr., 200 mtr., 400 mtr., 800 mtr., 400x100 mtr. Relay Race,

Long Jump, High Jump, Shot-Put, Discus Throw, Javelin Throw.

(one player cannot participate more than three events (except 4x100 meter relay race)

- 3. In this regard, the Selection Trials for Men and Women Athletics Team of CEA will be conducted at the Vinay Marg Sports Complex, New Delhi on <u>02nd March</u>, <u>2022 (Wednesday) from 2 PM onward</u>.
- 4. All the Men & Women officers/officials of CEA, who are interested to participate in the above said Selection Trials of Athletics may submit their nomination to Adm.(Coord.)/Welfare Section, CEA in the prescribed entry form, as given below, latest by 28th February, 2022. No entry will be accepted after the closing date.
- 5. Those officers/officials who will be selected after the Selection Trials for their participating in the above said Inter-CPSU Athletics Tournament 2021-22, must submit their final willingness along with enclosed "No Objection Certificate" from their respective controlling officers.
- 6. **Shri Satish Kumar** has been appointed as Selector (External appointed) of the above said Selection Trials. His decision will be final and binding and no further request will be entertained in any condition in this regard.

- 7. All the participants are requested to report to the above said Selector at the above said venue on 02.03.2021 at 1.30 PM Sharp. Those who are not in proper kit, will not be allowed to participate in the Selection/Trials.
- 8. Each player can participate only in two Inter-CPSU Tournaments. Manager/Coach can be selected only for one Inter-CPSU Tournament. <u>Nomination/request exceeding the said numbers will not be entertaining for any further Inter-CPSU Tournaments 2021-22</u>.
- 9. <u>Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)-Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:</u>
- 10. All the players are directed to follow these guidelines/protocol/instructions strictly during the selection trials as per Annexure(I). Check-List for Covid-19 is also required to be filled at the Venue(Annexure-II).



Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)-Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:

- 1. A <u>SCREENING CHECK LIST</u> for COVID-19(Annexure-I) is mandatory to fill up at the venue.
- 2. Fully vaccinated or Negative RT-PCR Report is required for participation in Trials/Tournaments.
- 3. While coming at the venue, all the Players/Officials may ensure and implement the instructions strictly as issued by the MHA and DoPT time to time and Circular(SOP) issued by M/o YA&S, dated 26.12.2020 & 29.01.2021 respectively i.e. social distancing, wearing face cover/mask, time to time hand sanitization, strict ban of gutka/Tobacco etc. and spitting should be strictly prohibited, stagger the lunch break of staff, to ensure social distancing etc.
- 4. Personal equipment such as Kit Bag, Racquets, Ball, towel, wrist band, head band, shoes, T-Shirt, Short etc. shall be used without sharing.
- 5. While not in playing hall, wash your hands with soap even when hands are not visibly dirty. Use of alcohol based hand sanitizers can be made wherever feasible.
- 6. Face cover/mask have to be worn at all times at inside or outside the venue except playing match at the playing arena. Use covered dustbins to manage used masks and waste materials.
- 7. Distance of 6 feet shall be maintained while sitting or walking inside or outside the venue.
- 8. Use of 'AROGYA SETU' app: Arogya Setu enables early identification of potential risk of Infection thus act as a shield for individuals and the community. With a view to ensuring safety at the venue, all the Players & Officials should ensure that 'AROGYA SETU' is installed by them in their compatible mobile.
- 9. If any Player/Official or his/her family member/relative is suspected/tested for COVID-19 to whom the Player/Official has been sharing common living space or has been in contact, then it is expected of the concerned Player/Official to inform the S.O.(Welfare)/Covid Task Force at venue/office immediately and refrain from attending the selection trials/office to prevent risk of exposing others in the tournament/office as has been specified in the **Standard Operating Procedure (SOP) issued by M/o H&FW** time to time.
- 10 Strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly. Spitting will be strictly prohibited.
- 11. No hand shake with player and umpire and high five is allowed.
- 12. Equipment which is bound to be shared and utilized continuously like Badminton shuttle cock, Various game balls, racquets during the trials/tournament must be used carefully without using such equipment to rub/touch face, remove sweat, cover mouth white hyperventilating etc.
- 13. All the players/officials are requested to cooperate with the Selectors, who have also act as a Covid Task Force during the selection trials.
- 14. If it is found that above mentioned protocol/Guidelines is not followed by any player/official in the selection trials including inside or outside venue premises, he/she shall be liable to scratched from the selection trials.
- 15. All the Players/Officials are directed to follow these instructions without fail. Cooperation of All Players and Officials is crucial to contain the spread of infection.
