**विषय-** IIT दिल्ली में शैक्षणिक वर्ष 2022-23 के लिए अंशकालिक M.Tech/Ph.D./MBA कार्यक्रमों के लिए नामांकन- के बारे में।

**Sub- Nominations for Part-time M.Tech/Ph.D./MBA Programmes for the academic year 2022-23 at IIT Delhi- regarding.**

A MoU between CEA & IIT Delhi was signed in July, 2013. As per the operational paragraphs contained in the MoU, the following activities inter-alia are to be undertaken: - M.Tech part-time & Ph.D. part-time programmes in the Department of Mechanical Engineering, Department of Electrical Engineering, Centre for Energy Studies and MBA in frontier areas of Power Management will be made available for the officers of Ministry of Power, CEA, NPTI and CPRI on the recommendation of CEA/MoP as per the rules of the institute. The admission to these programmes would be made by the respective Departments/ Centers of IIT Delhi in their academic calendar. The norms/eligibility for admission would be decided by IIT Delhi as per the rules applicable for candidates from other Government Departments/CPSUs for admission to part-time courses. Such activities will be funded by CEA in respect of candidates from CEA & MoP. CPRI and NPTI will bear the expenditure for their respective candidates. It will be the responsibility of the **candidates to pre-register/apply, undergo the process of selection for a course to the respective department in IIT Delhi, as the case may be.**

Meanwhile it is requested that nominations of the candidates for the part time M.Tech/Ph.D./MBA programs for the academic year 2022-23 with the approval of Member of the respective Wing of CEA for candidates from CEA and Competent Authority in case of candidates from MoP, CPRI and NPTI may be furnished to R&D Division, CEA (at [ce-rndcea@gov.in](mailto:ce-rndcea@gov.in)) **by 04.04.2022**. In case, any nomination is received from CEA, RPC, RIO and RPSO office situated outside Delhi/ NCR the candidate may be temporarily posted in the R&D Division till completion of the course. The guidelines/norms for screening of nominations by CEA are **enclosed** herewith.

The candidates are requested to check their eligibility for courses from IIT Delhi website and fulfill the terms and conditions mentioned therein for admission. As per the information available on IIT Delhi website (<https://home.iitd.ac.in/pg-admissions.php>) the admission process shall begin from 14.03.2022 (12.00 noon) and **the last date for applying online to IIT Delhi for admission is 11.04.2022 (04:00 pm).**

5. No candidate would be selected (a) unless he / she has served at least 2 years (as on 31.03.2022) on regular basis & (b) if he / she has less than 5 years of service to the superannuation.
6. An undertaking shall be given by the selected candidate to the sponsoring office that he/she would serve in the sponsoring Department / entity at least for 3 years after getting the aforesaid Degree.
7. In case the selected candidate opts out during the programme or he/ she opts to leave the department before the completion of said 3 years of service, the fees paid on his/ her behalf by the sponsoring organization would be recovered from him/ her by the sponsoring Department.
8. Selected candidate shall perform all the assigned official works in time.
