

Sir,

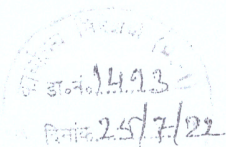
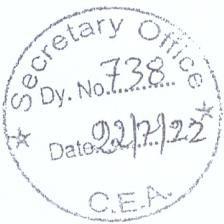
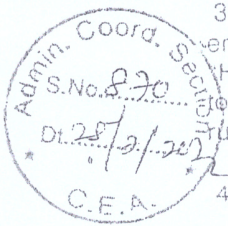
