- 2. Under the Chairmanship of Shri Manoj Tripathi(Director, HPM Division, CEA), first meeting of reconstituted Sports & Cultural Committee of CEA was held on 05.05.2019 at 03.00 PM. The following Sports matters were discussed during the meeting:
  - Selection Trials for participation in the Inter-Ministry and Inter-CPSU Sports Tournaments 2019-20 should be done well prior the respective tournament (approximately **prior to one Month).**
  - ii) For improvement of the standard of various Sports Team of CEA, after selection of team/individual, at least 10 days coaching/training/practice camp from 2.30 PM daily for intensive practice of respective team/individual prior commencement of the tournament should be organized.
  - iii) To meet the expenditure on sports materials for various team of CEA, budget provision may be enhanced from next year.
  - It is decided that for Inter-CPSU, one person be allowed to participate only in any two games. This decision may be strictly followed by the Adm.(Coord.)/Welfare Section, CEA at the time of issue of selection letters. If suitable players are not available, then such person can be allowed to participate in the third game subject to good player and knowledgeable about that game. A circular in this regard issued by Adm.(Coord.) Section at the earliest.
  - v) Those officers/officials, who are posted at field offices of CEA, should be included in the team directly on the basis of their performance in the previous tournaments.

- vi) Coaches/Managers of the respective teams, should be selected on the basis of their knowledge of particular games and also his/her experience of being Coach/Manager of that particular games. One person be allowed as Coach/Manager for one game only. This decision may be strictly followed by the Adm.(Coord.)/Welfare Section, CEA at the time of issue of selection letters.
- vii) For point No. ii, iii & iv, Shri Ashwani Kumar, S.O.(Welfare) & Convener of Sports & Cultural Committee may take up the matter with Admn. of CEA.
