INTER-CPSU CHESS SELECTION TRIALS FOR INTER-CPSU CHESS TOURNAMENT 2022-23 (06th to 07th September, 2022)

INSTRUCTIONS

- 1. Rules & Regulations of the Selection Trials will be followed as per World Chess Federation (FIDE).
- 2. Selection will start from 06th to 07th September, 2022 at CEA/BEE Recreation Club, Ground Floor, West Block-II, R.K. Puram, New Delhi. **If required, one more day extended**.
- 3. Schedule: Men/Women matches will start from 1 PM sharp daily.
- 4. Selecton-Trials matches will consist of <u>01 game/05 Rounds</u> and if necessary, tie break games. There shall be a pause of 10 minutes between all tie-break game, unless the Chief Arbiter decide otherwise.
- 5. Selection Trials will be played on **TOUCH & MOVE** basis.
- 6. Two Rounds will be played daily. 1 PM to 3 PM and 3.30 PM to 5.30 PM.
- 7. All the participants are requested to report well in advance preferably 15 minutes before the start of their respective match/s.
- 8. After the expiry of 30 minutes of the schedule time **Walkover will be given** and no request will be entertaining in this regard. Information should be given to Chief Arbiter of the Tourney, if participant is coming late.
- 9. Smoking and use of alcoholic in the CEA-BEE Recreation Club is strictly probhited.
- 10. No postponement of any game shall be allowed.
- 11. Any undisciplined player will be debarred from the Selection Trials by the Chief Arbiter or undersigned.
- 12. In case of any dispute during the Selection Trials, Chief Arbiter decision shall be final and binding.
- 13. Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)-Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:

All the players are directed to follow these guidelines/protocol/instructions strictly during the selection trials as per annexures.

- 14. Those officers/officials, who will be selected after the Selection Trials for their participating in the above said Inter CPSU Chess Tournament 2022-23, may submit their final willingness along with enclosed prescribed "No Objection Certificate" from their respective controlling officers.

Preventive measures to be taken to contain the spread of Novel Coronavirus (COVID-19)-Protocol/Guidelines/Instructions to contain the spread of disease in the Selection-Trials/Tournament:

- 1. A **SCREENING CHECK LIST** for COVID-19(Annexure-I) is mandatory to fill up at the venue.
- 2. Fully vaccinated or Negative RT-PCR Report is required for participation in Trials/Tournaments.
- 3. While coming at the venue, all the Players/Officials may ensure and implement the instructions strictly as issued by the MHA and DoPT time to time and Circular(SOP) issued by M/o YA&S, dated 26.12.2020 & 29.01.2021 respectively i.e. social distancing, wearing face cover/mask, time to time hand sanitization, strict ban of gutka/Tobacco etc. and spitting should be strictly prohibited, stagger the lunch break of staff, to ensure social distancing etc.
- 4. Personal equipment such as Kit Bag, Racquets, Ball, towel, wrist band, head band, shoes, T-Shirt, Short etc. shall be used without sharing.
- 5. While not in playing hall, wash your hands with soap even when hands are not visibly dirty. Use of alcohol based hand sanitizers can be made wherever feasible.
- 6. Face cover/mask have to be worn at all times at inside or outside the venue except playing match at the playing arena. Use covered dustbins to manage used masks and waste materials.
- 7. Distance of 6 feet shall be maintained while sitting or walking inside or outside the venue.
- 8. Use of 'AROGYA SETU' app: Arogya Setu enables early identification of potential risk of Infection thus act as a shield for individuals and the community. With a view to ensuring safety at the venue, all the Players & Officials should ensure that 'AROGYA SETU' is installed by them in their compatible mobile.
- 9. If any Player/Official or his/her family member/relative is suspected/tested for COVID-19 to whom the Player/Official has been sharing common living space or has been in contact, then it is expected of the concerned Player/Official to inform the S.O.(Welfare)/Covid Task Force at venue/office immediately and refrain from attending the selection trials/office to prevent risk of exposing others in the tournament/office as has been specified in the Standard Operating Procedure (SOP) issued by M/o H&FW time to time.
- 10 Strict practice of covering one's mouth and nose while coughing/sneezing with a tissue/handkerchief/flexed elbow and disposing off used tissues properly. Spitting will be strictly prohibited.
- 11. No hand shake with player and umpire and high five is allowed.
- 12. Equipment which is bound to be shared and utilized continuously like Badminton shuttle cock, Various game balls, racquets during the trials/tournament must be used carefully without using such equipment to rub/touch face, remove sweat, cover mouth white hyperventilating etc.
- 13. All the players/officials are requested to cooperate with the Selectors, who have also act as a Covid Task Force during the selection trials.
- 14. If it is found that above mentioned protocol/Guidelines is not followed by any player/official in the selection trials including inside or outside venue premises, he/she shall be liable to scratched from the selection trials.
- 15. All the Players/Officials are directed to follow these instructions without fail. Cooperation of All Players and Officials is crucial to contain the spread of infection.
