**Sub: Appointment on the post of Member, Madhya Pradesh Electricity Regulatory Commission (MPERC) – Inviting applications.**

Madhya Pradesh Electricity Regulatory Commission (MPERC) has been constituted with a Chairperson and two Members. One post of Member of MPERC is falling vacant with effect from 02.01.2023 due to retirement of existing Member. It has been decided to invite applications from the interested eligible person for selection to the post of Member in MPERC.

2. Qualification for appointment of Member:-

- (a) The Member shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management.
- (b) The Member shall not hold any other office.
- (c) The Member shall not be eligible for re-appointment as Member in Madhya Pradesh Electricity Regulatory Commission.
- (d) The Member shall hold the post for a term of 5 (five) years from the date he/she joins the office or till he/she attains the age of 65 years, whichever is earlier.

3. If the applicant is currently working in any organization, he/she will have to furnish following documents / information through the organization:-

- (a) Up to date and complete ACR for 5 years.
- (b) Vigilance clearance certificate
- (c) (i) Whether any penalty has been imposed on the applicant in the past



(If so, details thereof)

(ii) Details of penalty (if any) in operation against the applicant as on date.

(d) An undertaking that the organization has no objection in relieving the applicant in case he/she is offered appointment.

4. The applicant should not have any financial or other interest, which is likely to affect prejudicially his functioning as "Member of the Commission". A declaration in format given at **Annexure-I** should be furnished by the candidate alongwith his / her application, in this regard.

5. The salary, allowances and other terms and conditions of service of the Member shall be as prescribed by the State Government vide "Madhya Pradesh Electricity Regulatory Commission (Salary, Allowance and other service conditions of the Chairman and Members) Rules, 2000" as amended from time to time.

6. The last date of receipt of application is **02.11.2022**. The envelope containing application may be superscribed as "**Application for the post of Member, MPERC**". Applications received after due date will not be considered.


7. The applicants are requested to mention the following details in the resume:-
