Sub: - Regulatory Affairs Division as Coordination Division for all Regulations.

Regulatory Affairs Division (RA) will henceforth be the Coordinating Division for all Regulations of Central Electricity Authority. The Nodal Division (**Annex-I**) will be responsible for preparation of draft (for all stakeholders) including consideration of public comments for amendment, addendum, deletion etc to the respective CEA Regulations. All such drafts, seeking concurrence of the Authority, will be routed through the RA Division. RA Division will act as "Repository of all the Regulations issued by CEA and will ensure harmony and integrity among these Regulations".

2. Regarding the matters related to Regulations of CERC/ SERC, the RA Division will be the Coordinating Division for furnishing comments on behalf of CEA. Subject-wise Nodal Divisions have been identified for these Regulations. (**Annex-II**).

3. RA Division will be responsible for all correspondences with MoP, MNRE, CERC, SERCs, State Governments, etc as the case may be in respect of Regulations on above. Chief Engineer (RA Division) along with Chief Engineer of the Nodal Division may attend official meetings on behalf of CEA. Further, in case any information is required regarding the Regulations, all the Divisions of CEA will promptly send their comments to RA Division. The Nodal Divisions are expected to give the core input/ comment to the issue in such case.

4. Legal Division will be responsible for publishing the draft Regulation for public comments, and also finalizing Final Regulation after approval of the Authority. Legal Division will also be responsible for legal vetting of these Regulations. Likewise all MoP Rules will be coordinated by Legal Division of CEA.
