- 2. As per the aforementioned circular, MHA had clarified that as per its inquiries, Mr. Mahavir Prasad Tordi is not associated with or related to the office of Vice President of Nepal, and that he has been misleading people/authorities both in India and Nepal using fake letter heads.
- 3. In this regard, Ministry of External Affairs urges all State Governments/Union Territories/Departments of Central Government/PSUs to adhere to advisory of MHA and not entertain such requests of Shri Mahavir Prasad Tordi or related parties/Missions, if received by them.

Sir,

I am directed to state that a communication has been reported for making stay arrangements at Government Guest House for Shri. Mahavir Prasad Todi, alleged Special Advisor to the First and Current Vice President, Nepal and Governor Candidate for the Bank of England during his allegedly christened visit, "Indo-Nepal Samrasta Social Mission Yatra" to Delhi from the Government of Madhya Pradesh.

- 2. In this context, enquries have revealed that Mr. Tordi is not associated with or related to the office of current Vice President of Nepal. An official clarification has also been issued by the office of Vice President Nepal to the Press highlighting that Mr. Tordi had been misleading people/authorities both in Nepal and India by using Vice President's name and sometimes by using a fake letter head.
- 3. In view of the above, States/UTs are advised not to entertain such requests of Mr. Mahavir Prasad Tordi, if received by them, rather same should immediately be forwarded to MEA for establishing its authenticity.
