Minutes of meeting taken by Member (PS) CEA on 03.10.2017 to review the progress of transmission scheme "Immediate evacuation for North Karanpura (3x660MW) generation project of NTPC (ERSS XIX)" being implemented by M/s North Karanpura Transmission Limited (NKTL, A subsidiary of Adani Power Ltd) and issue of NOC from Ministry of Coal; and rescheduling of transmission system associated with Gadarwara STPP (2x800 MW).

List of participants is enclosed at Annexure - I.

2. Member (PS), CEA welcomed all the participants and requested Chief Engineer (PSPM) to take up the agenda of meeting. Brief of discussion is as under;

# A. North Karanpura (3x660MW) generation project of NTPC (ERSS XIX)

- 3. CE (PSPM) stated that in the last meeting taken by Member (PS) on 21.07.2017 representative of Central Coalfields Limited (CCL) had informed that RECTPCL recommended routes of both lines (North Karanpura Chandwa 400kV D/C line and North Karanpura Gaya 400kV D/C line) had been discussed in Board meeting held on 13.07.17 and also informed that matter would be taken up with Ministry of Coal (MoC) for approval of routes as soon as minutes are issued. Accordingly CCL had taken up the matter with MoC vide their letter dated 01.08.17 and CEA had also requested MoC vide letter dated 11.08.17 to expedite the clearance.
- 4. Representative of Ministry of Coal informed that they have received letter from CCL for approval for NoC to the routes of North Karanpura Chandwa 400kV D/C line and North Karanpura Gaya 400kV D/C line and the matter is under consideration. The approval would be accorded soon.
- 5. NTPC representative stated that the generation unit –I is scheduled to synchronized by Nov'18 for which they would require startup power from Jun'18 and they requested for early resolution of the issue by MoC so that the North Karanpura Chandwa 400kV D/C line is in place for supply of startup power.
- It was decided that the matter may be taken up with MoP so that the issue of NoC to North Karanpura Chandwa 400kV D/C line and North Karanpura Gaya 400kV D/C line can be expedited.

## B. Rescheduling of ATS of Gadrawara STPS (2x800 MW) of NTPC

1. CE (PSPM) stated that NTPC had requested to postpone commissioning of remaining elements i.e. (1) Gadarwara STPS- Warora P.S. (New) 765kV D/C line,

- (2) LILO of both Ckts. of Wardha Parli at Warora (New) Pooling Station and (3) 2x1500 MVA, 765/400 kV Warora (New) pooling station beyond Nov'17 as their generation unit -II would be commissioned by Mar'18. Accordingly, issue was discussed with Powergrid Warora Transmission Ltd (PWTL) in the meeting held on 10.08.2017 wherein PWTL informed that they may postpone balance elements of transmission scheme by two months i.e. Jan'18 and LTTC approval would also be required.
- 2. Madhya Pradesh Power Management Company Ltd. (MPPMCL), the lead long-term transmission customer (LLTTC) of the transmission scheme, informed that they have no objection, provided no penalty is levied on beneficiaries and confirmation would also be required from other beneficiaries of transmission project for rescheduling of transmission scheme. Member (PS) advised MPPMCL to consult other beneficiaries of the transmission project and submit reply within 15 days.
