Minutes of Meeting held under the chairmanship of Chief Engineer (PSPM Division), CEA on 27-06-2024 to review the progress of intrastate transmission projects matching with construction of ISTS planned to meet the increasing ATC requirement of Gujarat, transmission projects under Green Energy Corridor- I and transmission projects targeted for FY 2024-25. - reg.

- 1. Chief Engineer, Power System Project Monitoring (PSPM) Division, CEA welcomed all the participants and stated that the meeting has been organized to review/discuss the progress and issues involved (if any) in respect of following transmission projects related to Gujarat Energy Transmission Corporation Limited (GETCO).
  - a) Intrastate transmission projects matching with construction of ISTS transmission system planned to meet the increasing ATC requirement of Gujarat
  - b) Transmission projects under Green Energy Corridor- I
  - c) Transmission projects targeted for FY 2024-25.

He requested the representative of GETCO to inform the status of physical progress and issues involved in the transmission projects one by one.

- 2. The project wise detailed status as per the discussion held/information provided by representative of GETCO in the meeting is attached at Annexure III (Intrastate transmission projects matching with construction of ISTS transmission system planned to meet the increasing ATC requirement of Gujarat and transmission projects under GEC) and Annexure IV (Transmission projects targeted for FY 2024-25). Progress of intrastate projects and brief of some of the important issues deliberated in the meeting are as given below:
- 3. Details of Intrastate transmission projects matching with construction of ISTS planned to meet the increasing Available Transfer Capacity (ATC) requirement of Gujarat:

Chief Engineer (PSPM) raised concern about the mismatch in anticipated COD of ISTS transmission Projects (implemented by POWERGRID) and their connected downstream Network (implemented by GETCO). He stated that in absence of downstream network, the ISTS network will remain unutilized/underutilized. Hence, GETCO need to expedite the construction work of downstream networks in order to complete the intrastate project in matching timeframe of the ISTS network planned to cater to the increasing ATC of Gujarat.

## • Intrastate transmission projects planned to meet the ATC requirement of Gujarat by 2026-27:

#### West Gujarat:

Representative of GETCO informed that except "400 kV D/C Kalavad – Saurashtra line (awarded in March'24)" all other intrastate transmission projects in West Gujarat that have been planned matching with construction of ISTS are yet to be awarded (the project wise detailed status attached at **Annexure III**).

### **Central Gujarat:**

Representative of GETCO informed that intrastate projects of central Gujarat has just started. Land acquisition for Balethi Substation is under progress. Route survey for connected lines will start after land acquisition.

#### **South Gujarat:**

It was informed that "Jhanor - Sayakha 400kV D/c (twin AL-59) line" has been awarded in March-2024. However, for "765 kV D/C Pachchham (Fedra) - Sayakha line" engineering work is in process and is yet to be awarded.

#### 4. Transmission projects under Green Energy Corridor (GEC):

#### GEC-I:

## GEC-II:

Representative of GETCO further informed that 6 Nos. intrastate projects planned (in West Gujarat & South Gujarat) to meet the ATC requirement of Gujarat by FY 2026-27 are also included under Green Energy Corridor-II (GEC-II). Out of 23 packages (TL:17 Nos. & S/s:6 Nos.), 15 packages have been awarded.

On being enquired about the timeline given by Ministry of New & Renewable Energy (MNRE) for award of the transmission projects under GEC-II, GETCO representative informed that all the transmission projects under GEC-II were expected to be awarded by June-2024. However, they have requested MNRE to extend the timeline to Dec-2024. He further informed that as GETCO is implementing its 765 kV transmission

project for the first time, they are taking more time. Chief Engineer (PSPM) suggested that GETCO, if needed, may take help of POWERGRID in deciding the technical specification etc. for 765 kV transmission system. He also requested GETCO to furnish the details of transmission projects under GEC-II along with status of award of packages to CEA so that proper monitoring could be done.

The details of transmission projects under GEC-II with their status of award (as provided by GETCO) is also attached at **Annexure III**.

#### 5. Transmission Projects included in FY 2024-25 target:

The detailed status along with physical progress of all the transmission projects (transmission line & substation of 220 kV & above) of Gujarat targeted for FY 2024-25 are attached at **Annexure IV**. However, brief of transmission projects having issues/delayed from its COD (provided during finalization of Target) is as below:

It was noticed that GETCO has achieved only 44 ckm of transmission line and Nil transformation capacity against the target of 135 ckm and 500 MVA in transmission line and transformation capacity respectively till May-2024.

**6.** Chief Engineer (PSPM) expressed concern about delay in the commissioning of transmission projects from its original COD (provided during finalization of target) resulting in less achievement. He advised GETCO to adhere to the commissioning timelines of the transmission projects as decided in the meeting and requested to expedite all projects targeted for completion within this Financial year so that projects are completed as per target. Further, he suggested that issues involved in projects must be resolved with the help of local administration / concerned agencies at the earliest for timely completion of the projects.
