PTCC proposal for LILO of both circuits of Ranchi - Maithon RB 400 kV D/C transmission line at Dhanbad (2.70 km)

The PTCC proposal submitted vide reference (i) has been examined. BSNL vide reference (ii) has intimated that no U/G cable crosses the proposed transmission line. However, BSNL has not submitted details of telecom cables in the vicinity of proposed transmission line, as per PTCC Manual 2010. Therefore, IV calculation on paralleling BSNL telecom circuits could not be carried out. The telecommunication details from Eastern Railway are pending. Meanwhile, power authority has shown urgency for the charging of the line. The low frequency induction on Block & Telecom circuits of Eastern Railway has been computed based on topographical map provided by the power utility. Voltages likely to be induced on paralleling Block & Telecom circuits of Eastern Railway under Single Line to Ground fault condition are enclosed at Annex-I. The screening factors, as applicable, have been considered. Vide ref. (iii) above, Defense have conveyed No Objection Certificate (a copy enclosed as Annexure-II).

Taking above into consideration, take necessary action regarding issuance of provisional PTCC route approval for LILO of both circuits of Ranchi – Maithon RB 400 kV D/C transmission line at Dhanbad.
