Telecommunication details from DG Signals, MoD are awaited however, vide reference (ii) and (iii) above, TANTRANSCO has shown urgency for charging the line for power evacuation and has requested for provisional PTCC clearance. TANTRASCO has submitted an undertaking that in case of any damage to telecom assets/ personnel of Defense due to the charging of this line, TANTRANSCO shall bear the cost for remediation of the same.

Taking above into consideration, necessary action for issuance of provisional PTCC route approval may be taken under intimation to this office. LF induction on telecommunication circuits of Defense, will be communicated after the receipt of details from DG Signals, MoD.
