The PTCC proposal submitted vide reference (i) and (iii) has been examined. The LF induction on communication circuits of BSNL with respect to details furnished vide above references (iv) has been computed. The voltage likely to be induced on paralleling communication cables of BSNL under Single Line to Ground fault condition are enclosed at Annexure-I. The screening factors as applicable have been considered. Southern Railway vide reference (v) has issued their No Objection certificate (NOC) for charging of the line.

As per the details submitted by BSNL vide reference (iv) above, no telephone exchanges are falling in the EPR zone of the proposed substation.

Telecommunication details from DG Signals, MoD are awaited however, vide reference (ii) above, M/s JSWNEL have informed that all construction related work of the transmission line has completed and the line is awaiting charging due to want of PTCC approval. So as to charge the subject

cited transmission line as per schedule, M/s JSWNEL has requested for issuance of provisional PTCC clearance and has submitted an undertaking that in case of any impact on telecom asset/ personnel of Defense due to charging of this transmission line, JSWNEL shall take all remedial action.

Taking above into consideration, necessary action for issuance of provisional PTCC route approval may be taken under intimation to this office. LF induction on telecommunication circuits of Defense, will be communicated after the receipt of details from DG Signals, MoD.
