The PTCC proposal submitted vide reference (i) has been examined. DET, PTCC (WZ), BSNL vide reference (iii) and GM (S&T), Western Railway vide reference (iv) has given their NOC for charging the line.

Telecommunication details from DG Signals, MoD are awaited however, vide reference (ii) above, M/s ARPFPL has informed that all the construction related work has been completed and the plant is awaiting charging due to want of PTCC approval. M/s ARPFPL has requested for issuance of provisional PTCC clearance and has given an undertaking that *"In the event that the charging of the said transmission lines leads to any interference with telecom assets or any impact on personnel or installations of Defence authorities, M/s ARPFPL shall take all remedial measures and no other utility shall be held liable for this"*.

Taking above into consideration, necessary action for issuance of provisional PTCC route approval may be taken under intimation to this office. LF induction on telecommunication circuits of Defense, will be communicated after the receipt of details from DG Signals, MoD.

  - CEA Registration Number: GUJ-939
- 33 kV SPSC line from **Jatavira Solar Block 1** to the proposed **220/33 kV Pooling Substation at Devsar village, Taluka Nakhtrana, Kachchh District, Gujarat**

We had submitted the PTCC application on 24.02.2025 to CEA, BSNL, Railways, and MoD for obtaining necessary No Objection Certificates (NOCs). Our cases were subsequently registered with CEA under the above-mentioned registration numbers.

As part of the process, we confirm receipt of the following:

- BSNL Recommendation Letters for both transmission lines.
- Railway NOCs granting clearance for the above transmission infrastructure.

In view of the above, we **request your good office to kindly provide us with a Provisional PTCC Approval** for the energization of the said transmission lines, as the construction work has been completed and the systems are in a ready-to-charge condition.

Furthermore, in the event that the charging of the said transmission lines leads to any interference with telecom assets or any impact on personnel or installations of the Defence authorities, we hereby undertake to take all necessary remedial measures to resolve the issue. We affirm that no other utility or organization shall be held responsible for such remediation.

We also undertake to comply fully with all guidelines, directions, and conditions issued by PTCC and the concerned authorities.

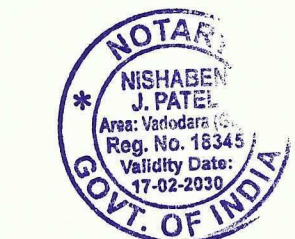
