Minutes of first meeting of Registration Committee constituted under D/o Expenditure Order (Public Procurement No.1) No. 6/18/2019-PPD dated 23.07.2020 held on 07.08.2020 at 12.30 Hrs in Room No. 141, Udyog Bhawan, New Delhi

List of participants is annexed.

2. First meeting of the registration committee was held in DPIIT on 07.08.2020 under the chairpersonship of JS(MKN). Initiating the discussions, the Chairperson welcomed the participants. Various points discussed during the meeting are detailed below in the succeeding sub-paragraphs.

a. In accordance with D/o Expenditure Order (Public Procurement No.1) No. 6/18/2019-PPD dated 23.07.2020, Registration Committee was constituted by DPIIT on 06.08.2020 to consider applications received for registration of bidders from countries which share land border with India for participation in public procurement with following composition:

- b. The draft application format for bidder registration was circulated to MHA, MEA and D/o Expenditure for comments vide OM dated 05.08.2020. Comments on draft application format for bidder registration are awaited.
- c. Representative of Department of Expenditure (DoE) was invited as Special Member for the first meeting of registration committee. However, representative of Department of Expenditure could not attend this meeting due to preoccupation with another meeting. However, DoE has stated that they will be sending their comments on draft application format for bidder registration by 12th Aug, 2020.
- d. Clause 10 (d) of Public Procurement (Preference to Make in India) 2017 provides 'if a Nodal Ministry is satisfied that Indian suppliers of an item are not allowed to participate and/ or compete in procurement by any foreign government, it may, if it deems appropriate, restrict or exclude bidders from that country from eligibility for procurement of that item and/ or other items relating to that Nodal Ministry'. So far only Department of Telecommunications identified list of Telecom items for action under Clause 10 (d) of PPP MII Order, 2017.
- e. Under existing procedures also, MHA and MEA accord security and political clearances for procurement of sensitive nature to various procuring entities on case to case basis.

3. Committee recommended that to lay down broad policy guidelines for proceedings and derive evidence based decision, it is advisable to obtain database on products / items / goods / services / works procured through public procurement in last three years including general assessment of foot print of bidders from countries which share land border with India from major procuring Ministries/Departments in the format enclosed as **Annexure –A.** For this purpose, committee recommended that inputs may be taken from Ministry of Railways, Ministry of Shipping, Ministry of Road Transport & Highways, Department of Telecommunications, Ministry of Housing and Urban Affairs and Ministry of Power.

Decision taken

- 4. After detailed discussions and deliberations, committee took the following decisions:
 - a. Ministry of Home Affairs, Ministry of External Affairs and Department of Expenditure to expedite comments on draft Application Format **at Annexure-B** for registration of bidders on priority.

(Action: MHA, MEA and DoE)

b. MEA and MHA to confirm that the guidelines for internal use regarding the procedure for scrutiny of applications for Registration under above DoE's Order dated 23.07.2020 are in place.

(Action: MHA and MEA)

c. Ministry of Railways, Ministry of Shipping, Ministry of Road Transport & Highways, Department of Telecommunications and Ministry of Housing & Urban Affairs and Ministry of Power to provide with due care classified information regarding products / items / goods / services / works procured through public procurement in last three years including general assessment of foot print of bidders from countries which share land border with India in the format enclosed as Annexure –A. MoR, MoS, MoRT&H, DoT, MoHUA and MoP to also provide comments on draft Application Format at Annexure-B for registration of bidders.

(Action: MoR, MoS, MoRT&H, DoT, MoHUA and MoP)

d. Details of the requests received in DPIIT for revocation of Clause 10(d) of PPP-MII Order and Nodal Ministries/ Departments response thereto will be shared by DPIIT with MHA and MEA.

e. The second meeting of Registration Committee **is scheduled at 2.30 PM on 13.08.**2020. Inputs on the above action points received will be reviewed with the representatives of above Ministries / Departments during second meeting of the Registration Committee.
