OFFICE ORDER

It has been decided that the works relating to DPCs/ Screening Committee meetings to be conducted by CEA as per MoP Letter No. A-36018/1/2014-Adm.I dated 9th June 2014 (covered under para (iii) of Annexure-I) shall be looked after by Shri G. Muthuraja, Deputy Secretary (B&A), CEA.

2. The proposals pertaining to the above mentioned works shall be put up by Under Secretary(P) to Shri G. Muthuraja, Deputy Secretary (B&A) for seeking approval of competent authority and conducting the DPCs/Screening Committee meetings. List of such proposals for holding DPCs/Screening Committee meetings is placed at **Annexure-1**. After holding DPCs/Screening Committee meetings, the same channel shall be exercised to obtain the approval of the competent authority accordingly.

3. However, the works related to DPC proposals where UPSC is involved, shall be looked after by Director (Adm.), CEA. These proposals shall be put up by US(P) to Director (Adm.) for seeking approval of the competent authority before forwarding the same to UPSC. List of such DPC proposals is placed at **Annexure-2**. After holding DPCs in UPSC, the approval of the MOS (I/C) for Power/ACC shall also be sought accordingly through the same channel.

4. This arrangement shall come into effect immediately.

This issues with the approval of Chairperson, CEA.



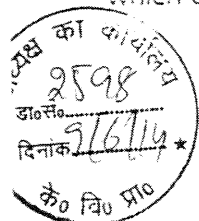
Madam,

In partial modification of this Ministry's letter No.6(18)/Fin/78 dated 09.07.1980 on the above subject, I am directed to convey the sanction of the Competent Authority to the delegation of the enhanced powers to the Chairperson, Central Electricity Authority (CEA), as detailed in **Annexure-I** (Administrative Authority) and **Annexure-II** (Financial Powers).

2. The Administrative Authority agreed to be delegated to Chairperson, CEA is at **Annexure-I**.

3. The Financial Powers thus vested in the Chairperson, CEA, may not be further delegated and will be exercised by her/him subject to the limitations, restrictions, procedures, scales etc., mentioned in the Delegation of Financial Power Rules, 1978, as amended from time to time, General Financial Rules, 2005, Fundamental and Supplementary Rules and other relevant orders issued from time to time.

4. While exercising Financial Powers as Head of Department, Chairperson, CEA shall consult Member (E&C) for financial concurrence. Also, all the financial powers delegated to Head of Department will be further subject to the conditions and limitations as laid down in DFPRs, economic instructions/rules/orders/ guidelines etc. issued by Ministry of Finance from time to time. All orders pertaining to financial release should indicate that such orders are issued with the concurrence of Member (E&C) and also bear their Diary No. and date vide which concurrence was given.

Annexure-I**[F.No.A-36018/1/2014-Adm.I dated: 06.06.2014]****ADMINISTRATIVE AUTHORITY DELEGATED TO CHAIRPERSON, CEA**

(i) Forwarding of Departmental Promotion Committee (DPC) proposals for promotion of officers of Central Power Engineering (Group 'A') Service (CPES) from AD Grade-II to AD Grade-I, Director and Chief Engineer level directly to UPSC;

Proposals for the promotion of officers from AD Gr.II to AD-I, Director and Chief Engineers may directly be sent to UPSC by CEA. The proposal of CEA for approval of Hon'ble MoSP(I/C) will be routed through Administrative Division, Ministry of Power.

(ii) Direct correspondence of CEA with the UPSC for filling up vacancies of CPES Group A / Group B officers for the posts of Assistant Director Grade-I/Grade-II;

CEA may directly submit the requisition to the UPSC under intimation to MoP. Dossiers of the selected candidates may be received directly in CEA from the UPSC/Railway Board to enable CEA to expedite the process of joining of the candidates following the due procedure. The proposal of CEA for approval of Hon'ble MoSP(I/C) will be routed through Administrative Division, Ministry of Power.

(iii) Delegation of powers to CEA to conduct DPCs for probation/ confirmation at AD Grade-I/Grade-II, promotion at Deputy Director level and Grant of Non-Functional Upgradation of CPES Officers;

Proposals relating to probation/confirmation at AD Gr-I/Gr-II, promotion to Deputy Director level and Non-Functional Upgradation of CPES Officers may be prepared and processed in CEA for conducting DPC. The proposal of CEA for approval of Hon'ble MoSP(I/C) will be routed through Administrative Division, Ministry of Power.

(iv) Delegation of powers to CEA to issue vigilance clearance for CPES Group 'A' officers;

All vigilance clearances for CPES Gr.A officers may be issued by CEA with the approval of CVO, CEA.

(v) Delegation of powers to Chairperson, CEA to approve ex-India official visits of CEA Officers going abroad

In the case of officers, other than Chairperson, Members, Principal Chief Engineers and Chief Engineers of CEA, permission for foreign official visits may be granted with the approval of Chairperson, CEA. In other words, Chairperson, CEA would be competent to grant permission for foreign official visits in respect of officers up to the Director level, subject to availability of budget, economy instructions and mandatory clearances (Political clearance from MEA, FCRA clearance from MHA wherever foreign hospitality is involved, concurrence of IFD).

1	Petty work and repairs [Sl.No.12 of Schedule-V of DFPRs] (i) Execution of petty works and special repairs to Government owned buildings, including sanitary fittings, water-supply and electric installations in such buildings and repairs to such installations. (ii) Ordinary repairs to Government building. (iii) Repairs and alteration to hired and requisitioned buildings	As per Annexure to Schedule-V of DFPR, (i) Powers to incur expenditure on sub-items (i) and (iii) up to the monetary limits indicated below- [(i) Rs.30,000 in each case. (ii) Rs.50,000 per annum non-recurring. Rs.6,000 per annum recurring.] (ii) In exercising these powers, the provisions of Rules 126 and 133 of the General Financial Rules, 2005, shall be observed. 3	Postal and Telegraph charges. [Sl.No.13 of Schedule-V of DFPRs]	Full power , subject to the provisions/conditions laid down in Annexure to Schedule -V of DFPRs [CEA may also explore using modern methods of communication to reduce expenditure towards this Head.]
4	Printing and Binding [Sl.No.14 of Schedule-V of DFPRs]	Financial power of Chairperson, CEA is enhanced from the existing Rs.10,000/- p.a. to Rs.20,000/- p.a. subject to the conditions/provisions laid down in the DFPRs.

All orders pertaining to financial release should indicate that such orders are issued with the concurrence of Member (E&C) and also bear their Diary No. and date vide which concurrence was given.

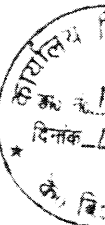
