**Subject: Amendment in OM regarding BCOT dated 31.01.2013.**

Following amendments are made in OM No. 1/5/2013-Adm.I(CEA) dated the 31<sup>st</sup> January, 2014 related to BCOT, with immediate effect:

**Para-1:** In pursuance to the directions of DoP&T for compliance of the Judgement dated 31.10.2013 of the Hon'ble Supreme Court in WP(Civil) No. 82/2011 in the matter of Shri T.S.R. Subramanian & Others Vs. Union of India & others, it has been decided to constitute a Board in Central Electricity Authority(CEA) to enable and facilitate transfer/posting of CPES officers of CEA.. This Board is named as '**Board for CPES Officers transfer/posting '(BCOT)**'. The Board shall recommend cases for transfer/posting of CPES officers from headquarter to subordinate offices & vice versa and amongst the subordinate offices of CEA.


