ORDER

Consequent upon enactment of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, which came into force with effect from 9th December, 2013 and with the approval of the competent authority in Central Electricity Authority (CEA), it has been decided to reconstitute the Internal Complaints Committee (ICC), in supersession of the earlier ICC constituted vide this Authority's Order No.2/3/2006-Vig. dated 31st October, 2013. The composition of the Internal Complaints Committee in CEA, so reconstituted, will be as under :



2. The Committee will examine the complaints regarding sexual harassment of women employee(s) and, if necessary, conduct an enquiry. On completion of the same, the Committee will submit its findings to Chief Vigilance Officer, CEA for further necessary action.

3. The Committee will make itself effective and functional at all times. It should also meet once in a quarter even if there is no live case and review the preparedness to fulfil all requirements of Vishaka Judgement in the CEA.

4. The Committee will also submit an annual report of the complaints received and action suggested by the Committee to Administrative Wing of this Authority.
